VENUE : PREKSHA VIHAR, KIRORJIMAL PARK, BHIWANI (HARYANA)

Bhiwani is 125 Km from Delhi well connected by Trains and Road Transport
Bhiwani is popularly known as Chhoti (small) Kashi.



ELIGIBILITY : Unrated and ELO Rating of below 2200

AICF REGISTRATION : All participants should get their names registered with AICF. Registration forms will be available at the venue on payment of Rs. 250/- for the year 2011-12. No unregistered player will be allowed to participate in the tournament. If a player is already registered with AICF, he/she must show proof thereof.

PLAYERS ARE REQUESTED TO BRING THEIR OWN INTERNATIONAL CHESS CLOCK.

System of Play: The tournament will be played under the FIDE Laws of Chess

Session of Play and Time Control : Time control of 60 minutes each + 30 Second increment per move from move number one.

Tie Break : Latest Tie breaking rules will be applied.

Tournament Committee : A tournament Committee consisting of Chief Arbitrator, two members from Haryana Chess Association & two members from District Chess Federation shall be set up before commencement of the tournament.

Appeal Committee : Before the commencement of the tournament, a five member Appeal committee with two reserves shall be formed by the organizers. No member of the committee shall vote on a dispute in which a player from his own state is involved and in such case (s) the reserves shall take his/his places in the committee.

Protests : Protest, if any, against the decisions of the Chief Arbitrator must be made in writing within 15 minutes of the incident with a protest fee of Rs. 500/- which shall be refunded if appeal is upheld. The decision of the appeals committee shall be FINAL and BINDING on all the participants.

Lodging : Free dormitory type of lodging will be provided to All Players registered their name in time.
